Greetings

Greetings from Chair of Organizing Committee

It is our honor to host the 13th meeting of exchange among Japan, China, and Korea in the fields of intellectual property. We are holding this year's meeting in Nara, the ancient capital of Japan, where a large number of historic shrines and temples are conserved. After the meeting, you can take part in an excursion to places of historic interest if you like. We hope you will enjoy the beauty of the Japanese ancient capital.

As topics of the meeting, the Japanese Group proposed the following and gained consensus from the other Groups:

1. Updates on intellectual property systems in each country
2. Employee invention system
3. Trade secrets

The purpose of Topic 1 is to provide updates on IP systems including law amendments.

In connection with Topic 2, Japan implemented the second revision in recent years in consideration of disagreement expressed by industries as to ownership of and compensation (or rewards) for such inventions. We would like to talk about what system exists and whether there are any problems related to the employee invention system in each country.

We picked Topic 3 from the Working Questions for the AIPPI Congress in Rio de Janeiro this year. We hope discussions will focus on what system exists to provide protection and what the actual status is in each country.

I would like as many people as possible to attend this annual meeting. I hope that exchanges among the three countries will be promoted more than ever through the activities in the IP fields, which will contribute to further economic development of these countries.

(1) Byodo-in Phoenix Hall, a National Treasure (Garden, Museum "Hoshokan")

A Buddhist temple, closely related with the Fujiwara clan, located in the city of Uji, Kyoto

Registered on the World Heritage list as part of the "Historic Monuments of Ancient Kyoto," the temple has handed down its architecture, Buddhist statues, paintings, and garden from the late Heian Period (11th century) to the present.

The Phoenix Hall is also well-known as its image on the 10 yen coin.



(2) Uji River Cruise

On a sightseeing boat, you can enjoy a beautiful landscape of the Uji River that seems to change its appearance with the passing of the seasons.

(3) Lunch at "Kisen Chaya"

Rich in ingredients produced in Uji, Kyoto, each dish is filled with gifts from the four seasons.

(Todai-ji's Great South Gate, Great Buddha Hall, Nigatsu-do, Sangatsu-do)

One of the most popular tourist destinations in Japan.
